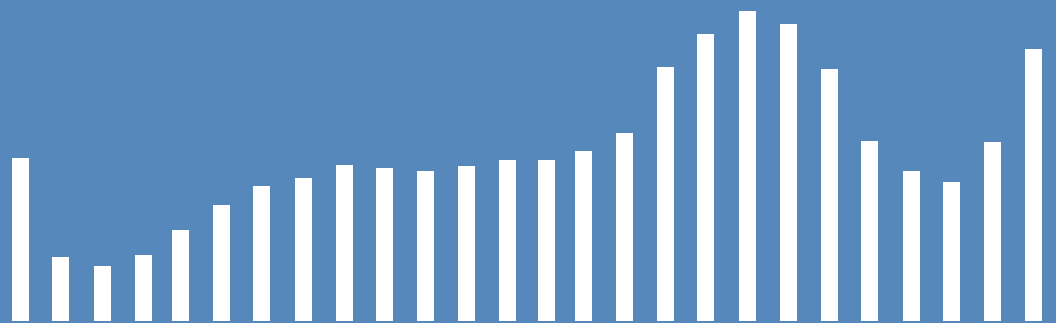

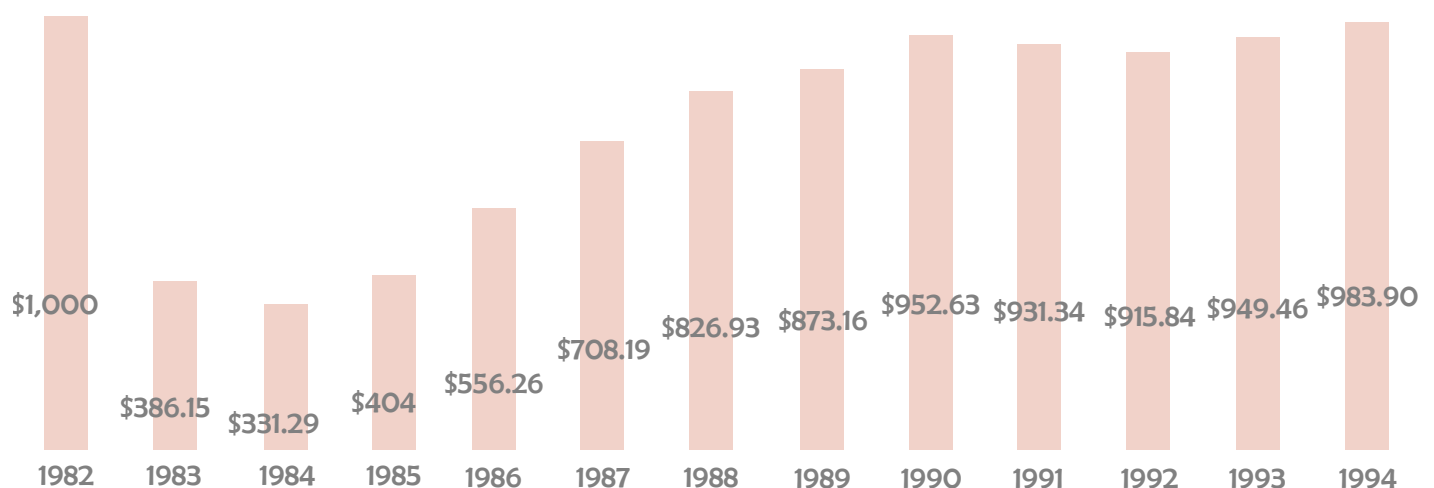


## Director's Notes

As the Director of the Permanent Fund Dividend Division (PFDD), I am focused on improving the public experience with the division. My goal is to see that applicants obtain accurate and timely resolution to eligibility determinations as well as timely response to questions and concerns. My direction to staff is to continuously look for ways to provide the best customer service possible while reviewing applicant cases, in person and through interagency cooperation. Each issue that arises is an opportunity to evaluate policies and procedures used to administer the PFD program and to make changes as needed. I continue to encourage staff to share their ideas about improving PFD business processes to meet this goal.

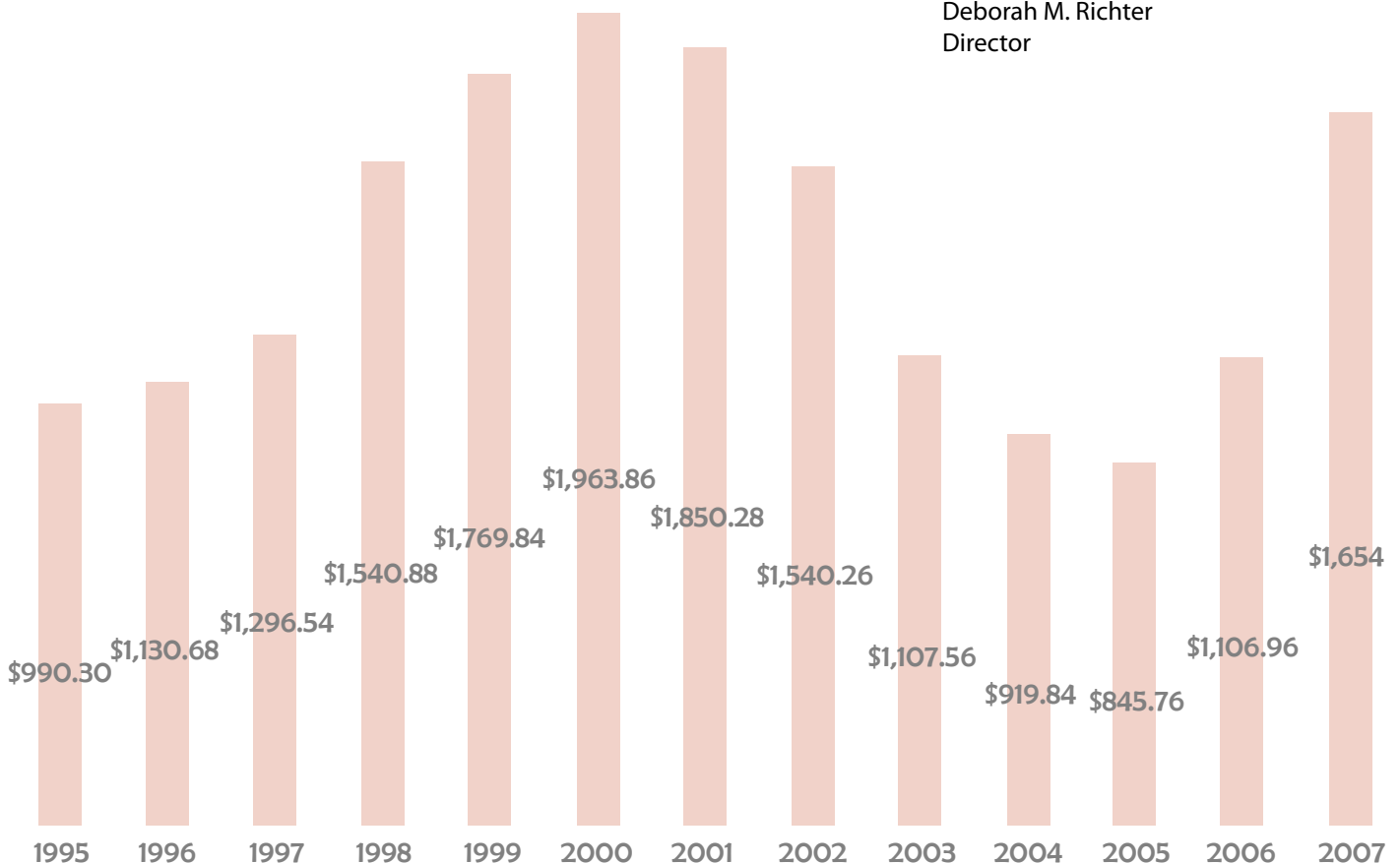


2007 was a banner year in the division's effort to move towards a paperless business environment. The public response to and use of the online application and electronic signature options continues to grow. PFDD implemented regulations changes which will allow authorized agencies and individuals to obtain PFD payment history online, further reducing paper requests. Additionally, the division streamlined the application review process and rolled out a new version of the Dividend Application and Information System (DAIS III) which will help to expedite PFD eligibility case work.

For 2008, the division's focus remains the completion of eligibility determinations on a time line that will make it possible to pay all eligible Alaskans on scheduled payment dates.

# Division

The Permanent Fund Dividend Division's (PFDD) yearly cycle starts January 1 when the **application period** opens. Alaskans may submit an application for a Permanent Fund Dividend during the filing period, January 1 to March 31. Currently, the busiest times of the filing period are the month of January, the current window for online applicants to qualify for the early direct deposit distribution, and the last week of March, the final week of the PFD filing season.

Applications received electronically are uploaded and electronically evaluated. Applications, supporting documentation and signature pages received on paper are imaged and keyed into the system and then electronically evaluated.

The work of making **eligibility determinations** begins as soon as applications are received by the division. Applications flagged by the division's computer system and requiring further review are assigned to eligibility technicians for evaluation primarily in one or more of the following areas: establishing residency, breaking Alaska residency, being absent from Alaska, and/or having the intent to remain in or return to Alaska. Guided by State of Alaska Statutes and PFD Regulations, eligibility technicians use the applicant information at hand or from previous years and, if needed, contact the applicant for additional information in order to make an eligibility determination. Many cases can be resolved without contacting the applicant. The current goal of PFDD is to complete this body of work by the scheduled payment dates in the fall.

Starting April 1, the division will accept claims for garnishments on individuals' PFDs. During May, a list of applicants and their Social Security numbers are submitted to the Internal Revenue Service for information matching. Those applicants whose information on file with PFDD does not match the information on file with the Social Security Administration are flagged. These applicants have the opportunity to correct their information during the summer months. Those applicants that do not correct their information will be subject to IRS withholding when their PFD is issued.

During July, the Permanent Fund Corporation transfers funds to PFDD that will be available for PFD distribution. PFDD calculates the dividend amount in September, and the governor announces the amount in late September.

**Payment of dividends** begins in October, currently with two direct deposit dates and one date for paper PFDs. October is a heavy month for public contact, and eligibility technicians have also been trained to provide **customer service** as needed, by phone, in person or by email.

During late November and early December the division focuses on **training**, finishing the work of eligibility determination, should records still need to be evaluated, and preparing for the next filing season.

Applicants that disagree with an eligibility decision may choose to file an appeal. Appeals are worked on a year round basis in a first come, first served manner.

Throughout the year, the division investigates hundreds of applications each year for potential **PFD fraud** based on tips or information received from the public. Additionally, the division conducts focused **audits** and investigates information that is obtained through the division's internal process and anomalies noted in processing applications.

PFDD is making a concentrated effort to bring internal **technology** up to speed as well as bringing applications, such as the website and phone systems, current with industry standards. PFDD is choosing to invest in technology that will allow applicants to more efficiently address their concerns and make their own changes to personal information, such as direct deposit information and address updates, via the PFD website.

The 18 year-old must meet all eligibility requirements for the respective prior year and must have filed the application prior to his or her 19th birthday. This regulation changed in 2008 to allow applicants until their 20th birthday to back file

<sup>3</sup>Sponsor Eligibility Forms apply to adults that do not apply for their own dividend but do sponsor a child application

<sup>4</sup>Applicants receive a partial direct deposit or payment when their dividend is garnisheed or assigned and the total amount garnisheed or assigned is less than the dividend amount. Applicants may assign up to 100% of their dividend, but only to federal, state or municipal agencies.

# Application Filing Activity 2007

The division received and processed 3,778 duplicate applications and 411 Sponsor Eligibility forms in 2007. These invalidated applications and forms are not counted in the filing activity. In total, the division received 633,084 2007 PFD applications and application-type forms.

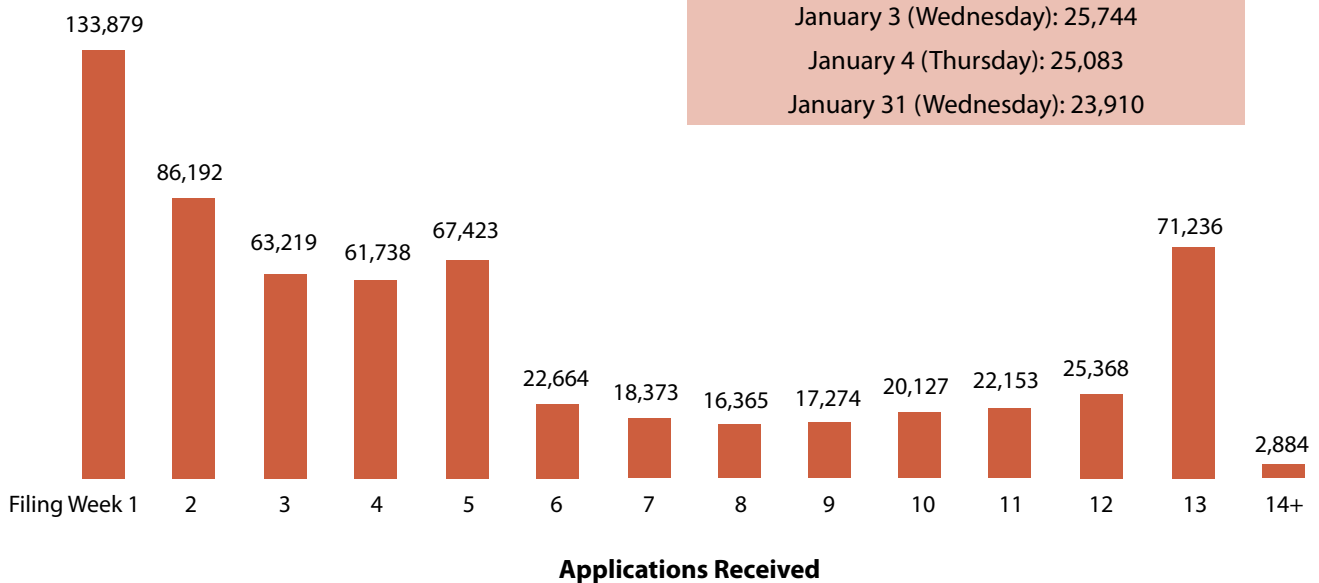

## Prior Year Dividend Payment Activity During 2007

### Prior year dividends are issued for the following reasons:

- 2006 dividend applications were still in review or appeal at the close of 2006
- Prior year 18-year-old filers. Alaska Statute 43.23.055 authorizes individuals who did not receive a dividend as a child to apply for missed dividends at age 18 or emancipation. These applicants must meet eligibility requirements and apply for any prior-year dividends within one year of their 18th birthday.
- Disabled adults and estates have an extended filing date of one year later than the original application deadline

## Eligibility Decisions - Initial Application Review

As applications are loaded into the PFD division's database, the computer flags applications which require further review. Eligibility Technicians review these applications. Technicians evaluate an applicant's establishment of Alaska residency, intent to remain an Alaska resident, reasons for absences from the state and compliance with PFD program physical presence requirements.

At the Initial Review stage, eligibility technicians screen and evaluate applicants' documents and past filing history. If additional information is required in order to make an eligibility decision, written requests outlining the information required are sent to applicants. Once applicants submit the requested information, Initial Review Eligibility Technicians re-evaluate the application taking the new information into consideration. An application may be denied at this stage or, if the application shows a complex eligibility issue or further contact with the applicant is necessary, it may be referred to a Final Review stage.

## Eligibility Decisions - Final Application Review

In the Final Review stage, eligibility technicians evaluate applications with complex issues that require in-depth analysis or further contact with the applicant. Technicians base decisions on all of the information that is available, including information that is obtained through telephone contact, email or written correspondence with the applicant and third parties. An application may be denied if the applicant does not meet the eligibility requirements of the PFD program. Eligibility Technicians assist with public response during January-March and September-October.

## Garnishments

Under Alaska state statutes, up to 80% of a Permanent Fund Dividend may be garnished. Government agencies have an exception and may garnish up to 100% of a dividend. Applicants are paid any amount in excess of the amount garnished.

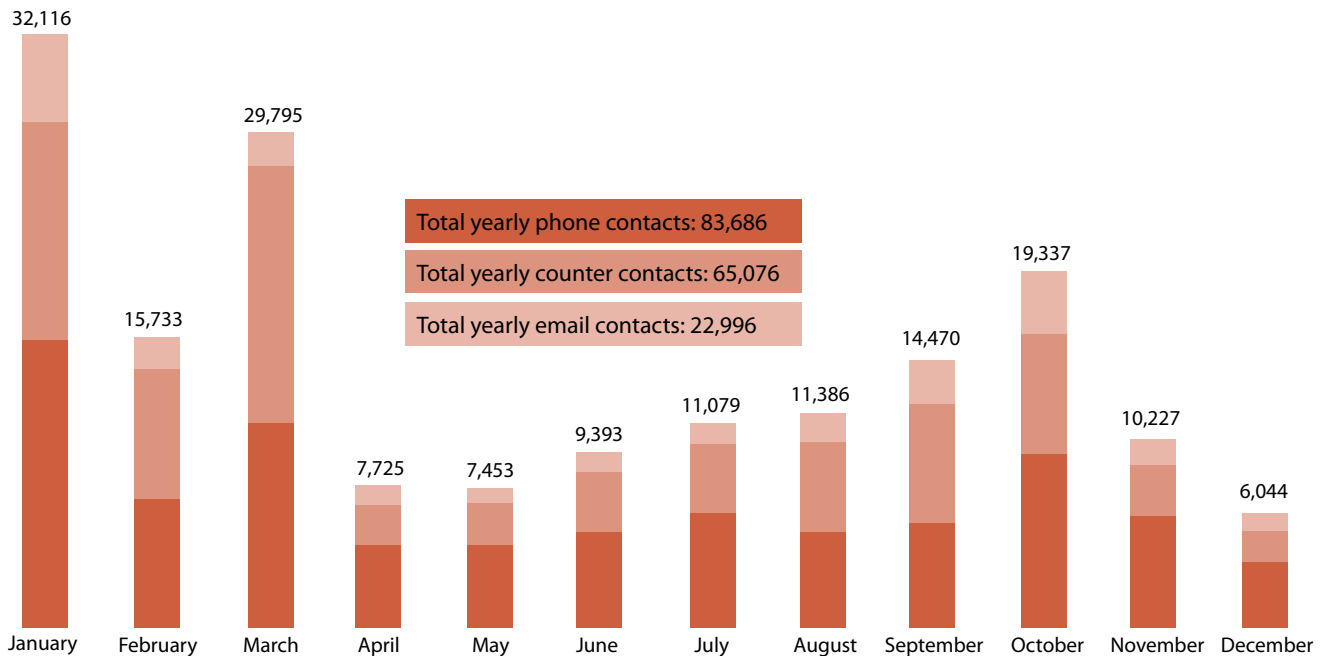

The application season, January-March, and payment season, September-November, are peak public contact times. Phone contacts have dropped by 21,345 from 2006 and are back in line with 2005 contacts. The spike in 2006 phone contacts can be attributed to the 2006 implementation of the early direct deposit. Counter contacts are up by 7,991 from 2006, and email contacts are continuing to climb as applicants make greater use of electronic media for communication.

# Appeals

Staff researches each appeal, determines the facts in the matters in dispute and issues written decisions. Formal appeals may be requested if an applicant chooses to dispute the informal appeal decision. Formal appeals are conducted by the Office of Administrative Hearings before an administrative law judge.

**Audit Information**

**Out of State Postmark audit** - Evaluates paper applications and signature pages that arrive in envelopes with out-of-state postmarks. Applications are denied in this audit primarily because of the applicant's failure to disclose that he/she had moved.

**Out-of-State IP Address audit** - Identifies online applications filed from out of state without disclosure of a corresponding absence. The originating IP Address is automatically collected by the division's online application system.

**Jury Questionnaire audit** - Evaluates applications of people excused from jury duty who are not Alaska residents or who were out of state for an extended period.

**Department of Motor Vehicles audit** - Evaluates information on individuals who apply to renew their driver's license or vehicle registration from out of state, or who receive traffic violations out of state and provide an out-of-state address to the issuing officer.

**Division of Elections audit** - Evaluates the names of individuals whose voter registration status has been deactivated because they have registered to vote in another state. The division denies those who registered to vote in another state during the qualifying period for the PFD.

**Direct Deposit audit** - Evaluates DD advices returned by the post office with out-of-state forwarding addresses. Under postal regulations, mail is not returned to sender with notice of the new address until the forwarding order has been in place for 12 to 18 months, indicating the applicants' may have moved prior to filing for a PFD.

**Bank Statement audit** -Evaluates applications of individuals who selected direct deposit using an Alaska address but who were having their Bank Statements mailed outside the state.

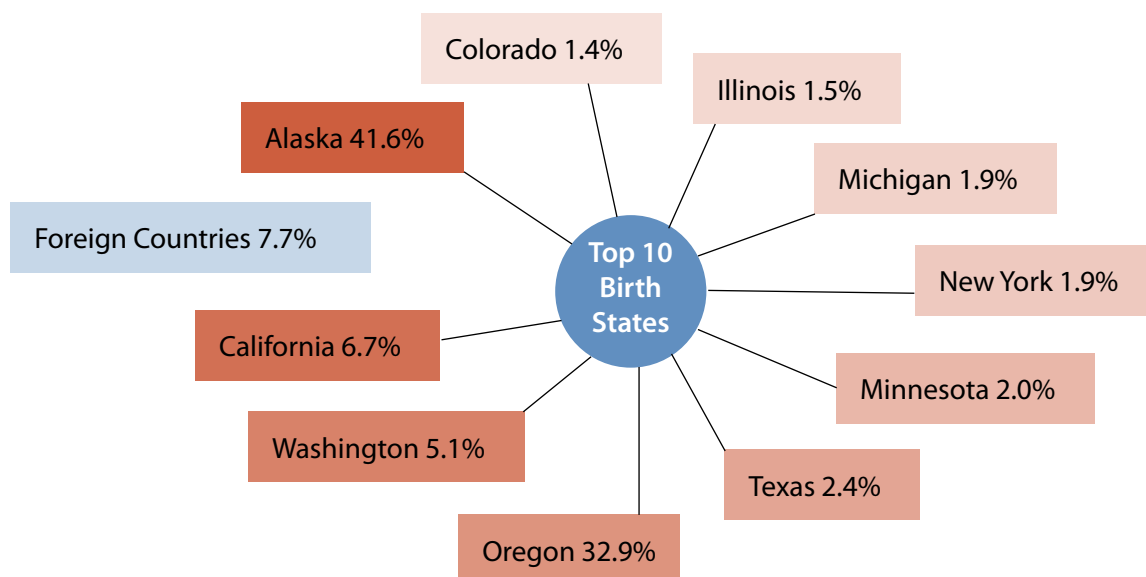

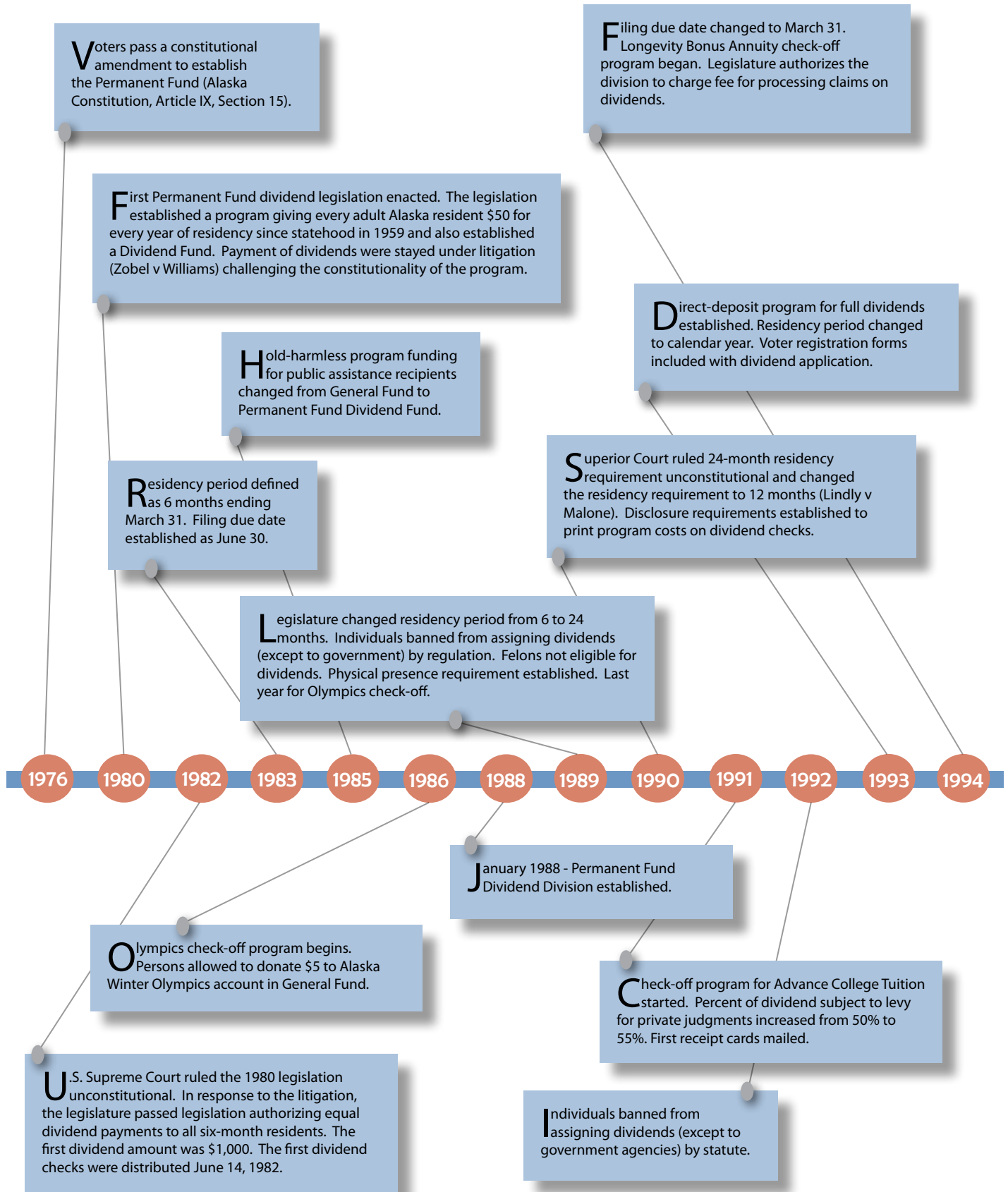

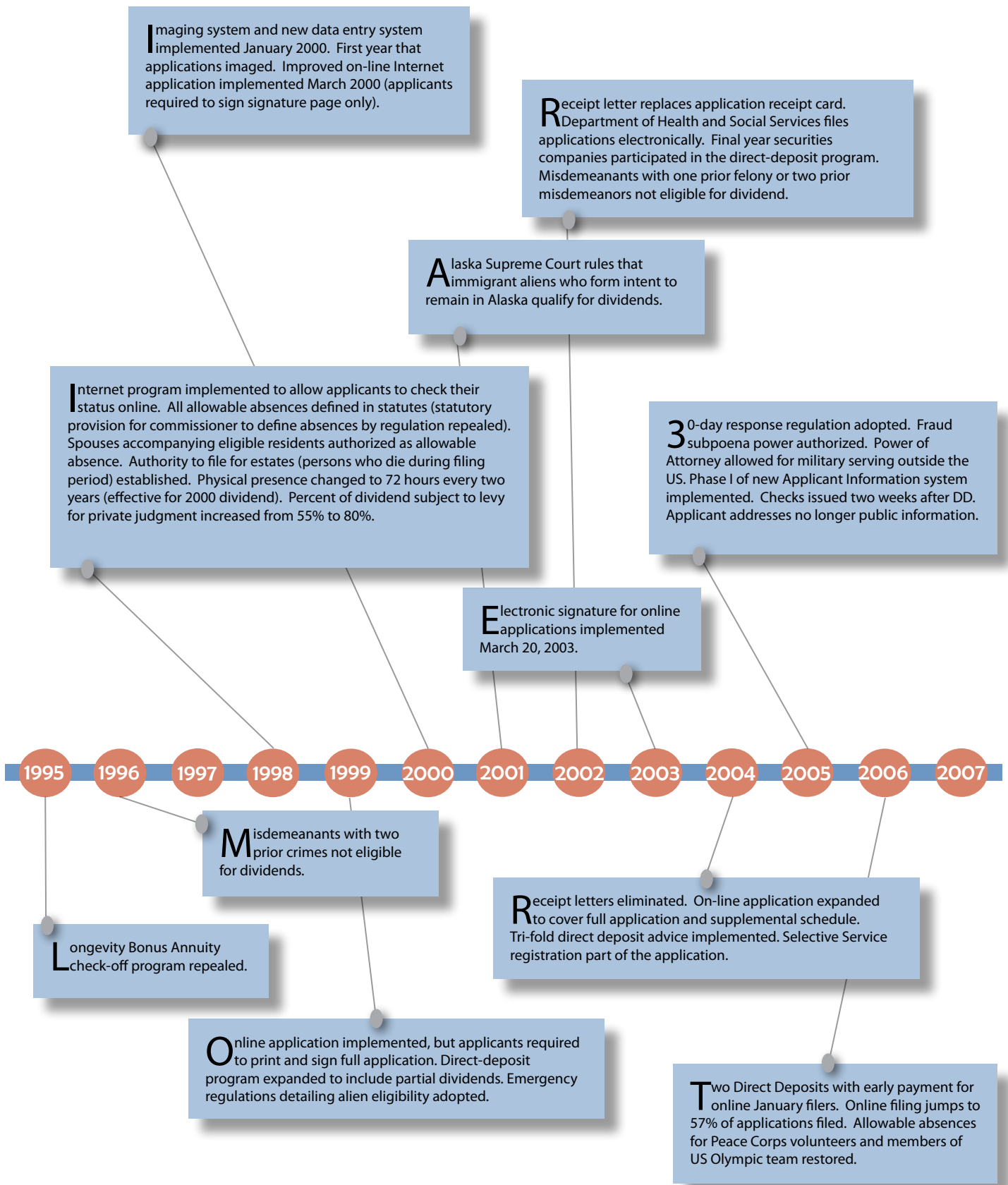

## Historical Summary Applicant Contributions to UA College Savings Plan

In 1990, legislation establishing the Alaska Education Trust Fund (AS 14.40.807) and authorizing an allowance for Permanent Fund Dividend applicants to contribute 50% of their dividend to the fund was passed. In 1991, the name of the fund was changed to the Advance College Tuition (ACT) Payment Fund. The ACT checkoff first appeared on 1991 dividend applications. In fall 2001, the University of Alaska developed the UA College Savings Plan program as the main program for which contributions can be made toward advanced college tuition costs.
