

During 2001, PFD employees processed over 1.6 million documents, including over 619,000 dividend applications.

The first dividends were issued to Alaskans in June 1982. Since the program's inception, the program has paid almost \$11 billion in dividends to Alaskans.

2001

This annual report provides information and data on the Permanent Fund Dividend Program for calendar year 2001. The 2001 dividend application period was January 2 through April 2, 2001. Alaskans who were residents of the state for the entire calendar year 2000 and met other requirements were eligible for a 2001 dividend.

This report includes highlights and data related to the PFD program for 2001 and historical data for prior years.

Executive Summary Section

This section provides an overview of highlights and accomplishments of the dividend program for 2001. It includes the dividend calculation and dividend activity for 2001 in comparison with prior year activity. This section also summarizes new Permanent Fund Dividend legislation enacted into law in 2001.

Detailed data and information specific to dividend activities are included in other sections of this report.

2001 in Retrospect

The 2001 dividend was the second highest since the program's inception in 1982. Although the dividend amount declined, the PFD Division experienced record activity in all other respects. During 2001, the division processed a record number of applications, paid a record number of dividends, and processed a record number of direct deposits and garnishment records.

Following are the division's highlights and accomplishments during 2001.

- ➤ **Second Highest Dividend** In September 2001, Revenue Commissioner Wilson Condon announced that the 2001 dividend would be \$1,850.28, a drop of 5.8% from the 2000 dividend of \$1,963.68. The dividend drop was due to the falling stock market.
- ➤ **Record Number of Applicants** The number of applicants grew slightly to 608,194 in 2001, up from 607,605 in 2000. The growth corresponds to an increase in the state's population as reported by the Alaska Department of Labor.
- ➤ **Record Direct Deposits** The upward trend of direct deposit for dividend payments continued in 2001. Nearly 75.4% of applicants requested direct deposit, up from approximately 73% in 2000. The total number of applicants who requested direct deposit for 2001 was 458,848, up from 443,713 for 2000. Direct deposits were posted to applicant accounts on October 10, 2001. Of the 458,848 requests, 404,247 applicants qualified for and received direct deposit. The total amount of direct deposit was more than \$735.5 million.
- ➤ Status Inquiry Hits at Record Level Record numbers of people continued to log onto the Internet in 2001 to check the status of their PFD application, whether payable, in review or denied. The number of inquiry hits edged up slightly to 371,565, up from 371,248 hits in 2000. October had the most number of hits with 62,670 hits. The status inquiry site had more hits than any other state Internet site for 2001.
- **Record Garnishments** The division processed a record number of garnishments in 2001. The total number of garnishments was 147,659, up from 143,454 in 2000. The growth in garnishments was attributable to an increase in orders submitted for collection.
- ➤ Online Application The division continued with its online application system that was implemented late in the 2000 application period. During the 2001 application period, the division received 48,994 online applications. Upon completion of the application period, the division decided to change direction for the 2002 online application. The 2001 online application system required that the applicant download viewer software in order to file online, and the slow process was a deterrent for many people who wanted to file online. For the 2002 online application, the division implemented a new system that does not require downloading software for filing.
- ➤ **Review and Appeals Consolidation** In March 2001, the division consolidated the previously separate Review Unit and Appeals Unit into one unit and named it the Dividend Enforcement, Review and Appeals Unit. The consolidation allows

management flexibility to assign work to employees depending on caseload demands during peak times.

- ➤ Supreme Court Decision Regarding Aliens In July 2001, the Alaska Supreme Court issued a decision on dividend eligibility for Alaska residents who are not U.S. citizens. The decision addressed eligibility for persons residing in Alaska without permanent resident status as recognized by the Immigration and Naturalization Service (INS). Under the decision, the division is required to look at a non-resident's actions in forming intent to remain an Alaska resident when determining eligibility, even though they may not have permanent resident status with INS. The division had already been paying applicants who had permanent resident status and were otherwise eligible.
- > **Expanded Outreach Program** During the 2001 dividend filing period, the division increased its outreach efforts by visiting places such as soup kitchens, convalescence centers and military bases. The mission of the outreach program is to assist persons with the application process and educate them about the dividend program.
- ➤ **Military Brochure** In fall 2001, the division designed a new brochure to inform military personnel about filing for a dividend while serving out of state. The brochure was distributed in early 2002 to all military bases in Alaska.

New Legislation

The 2001 legislature passed one bill directly related to the dividend program. Governor Knowles signed the bill into law on July 5, 2001.

SB 105 (Ch 92 SLA 2001) – Incarcerated Misdemeanant with Prior Felony Not Eligible for Dividend. This bill amended the rules that disqualify misdemeanants from eligibility for the dividend program under AS 43.23.005(d). The bill expanded the rules to include incarcerated misdemeanants who were convicted of a prior felony. Prior to the amendment, incarcerated misdemeanants were disqualified only if they had been convicted of two or more crimes. With the amendment, an individual incarcerated for a misdemeanor during the dividend qualifying year with either a prior felony or two or more prior misdemeanors is not eligible for the respective year's dividend. This bill took effect July 6, 2001.





Organization and Responsibilities

During 2001, the Permanent Fund Dividend Division was staffed by 93 positions comprised of 58 full-time, 5 seasonal and 30 temporary positions (primarily employed for data entry). The division is headquartered in Juneau and has offices in Anchorage and Fairbanks. The division's Fiscal Year 2002 operating budget was \$5.1 million. The division is organized into two components: *Operations, and Dividend Enforcement, Review and Appeals*.

OPERATIONS

Operations is responsible for receiving and processing dividend applications, processing dividend payments, and providing assistance to Alaskans who need help with their application or have questions regarding the dividend program.

Operations is organized into four units: *Document Processing and Image Control, Data Entry, Dividend Information Offices, and Data Processing.*

Document Processing and Image Control is responsible for (1) receiving, preparing and scanning dividend applications for data entry, and (2) processing applications that are incomplete or flagged by the division's computer system as requiring further attention. All applications and documentation are scanned and saved as electronic images. Employees throughout the division access the images for all functions, from data entry to helping applicants with questions concerning their application.

Document Processing and Image Control processes thousands of pieces of mail other than applications. Throughout the year, applicants submit documentation requested by the division to complete their application for processing.

Data Entry is responsible for entering application data and garnishments into the computer system. Data Entry is also responsible for providing accounting support and collecting dividends from persons who were deemed ineligible after having been paid a dividend.

The division employed 30 temporary employees to data enter 2001 dividend applications received during the filing season (January through March 2001).

Dividend Information Offices are responsible for assisting applicants who need help with completing their application or responding to information requests by the division. Information offices are located in Anchorage, Fairbanks and Juneau.

Information office staff assists applicants in person, by telephone, letter or e-mail. During 2001, the information offices assisted over 56,000 walk-ins and fielded over 112,000 telephone calls from applicants seeking assistance or requesting application forms. Information office staff responded to about 26,000 e-mails from applicants seeking information or assistance.

Data Processing is responsible for writing and maintaining programs related to the division's databases and providing the division with data processing support. Data Processing is also responsible for supporting the division's data entry system and for ensuring that computer programs are in place to flag applications that are incomplete or need further processing.

Data processing is responsible for preparing files for dividend payment each October. The unit works with financial institutions to coordinate direct deposits to applicant accounts. The unit also works with other state agencies to coordinate printing and mailing of dividend checks.

DIVIDEND ENFORCEMENT, REVIEW AND APPEALS

Under this component, two teams of PFD technicians work review and appeals cases.

Enforcement

One employee is responsible for criminal investigations and following up on fraud tips from the public received throughout the year.

Review

Employees in this section are responsible for reviewing applications that have been flagged by the computer system for having a potential problem in one or more of the following areas:

- Establishing residency
- Breaking Alaska residency
- Absences not allowed by law
- Intent to remain in Alaska

Employees work with applicants to gather information needed to determine their eligibility under the dividend program. Some cases are resolved without contacting the applicant if the applicant submits sufficient information with the application.

For each ineligible applicant, staff issues a denial letter outlining the reasons for the denial and informing the applicant of his or her appeal rights.

Appeals

Employees assigned appeals cases are responsible for conducting informal conferences for applicants who disagree with their dividend denial. The employee reviews each appeal and develops facts and information relating to matters in dispute by the applicant. The employee issues written decisions to applicants upon conclusion of an informal conference. If the applicant disagrees with the informal conference decision, the applicant may request a formal hearing before a hearing examiner from the commissioner's office. A designated employee from Appeals represents the division at formal hearings.

Permanent Fund Dividend Division History

- 1976 Voters pass a constitutional amendment to establish the Permanent Fund (Alaska Constitution, Article IX, Section 15).
- First Permanent Fund dividend legislation enacted. The legislation established a program giving every adult Alaska resident \$50 for every year of residency since statehood in 1959 and also established a Dividend Fund. Payment of dividends were stayed under litigation (Zobel v Williams) challenging the constitutionality of the program.
- 1982 U.S Supreme Court ruled the 1980 legislation unconstitutional. In response to the litigation, the legislature passed legislation authorizing equal dividend payments to all six-month residents. The first dividend amount was \$1,000. The first dividend checks were printed and distributed June 14, 1982.
- 1983 Residency period defined as 6 months ending March 31. Filing due date established as June 30.
- 1985 Hold-harmless program funding for public assistance recipients changed from General Fund to Permanent Fund Dividend Fund.
- 1988 January 1988 Permanent Fund Dividend Division established. Positions with PFD responsibilities in Administrative Services (20), Enforcement (23), and Public Services (14) transferred to the new division. Enforcement and Public Services divisions eliminated.

57 full-time positions after transfer.32 non-permanent positions.

1989 Legislature changed residency period from 6 months to 24 months. Individuals banned from assigning dividends (except to government agencies) by regulation. Felons not eligible for dividends. First year of Supplemental Schedule. Physical presence requirement established.

57 full-time positions.54 non-permanent positions.

1990 Superior Court ruled 24-month residency requirement unconstitutional and changed the residency requirement to 12 months (Lindly v Malone). Disclosure requirements (program costs) for dividend warrants established.

59 full-time positions.56 non-permanent positions.

Application Filing Season

The dividend application filing season begins on January 2. Within a couple of days, thousands of applications pour into the division by mail and hand delivery. Within the first week of the application period, the division typically receives around 90,000 applications. The weeks that follow are hectic and busy as the division processes the thousands of applications that are received throughout the season. After the end of the filing season, the division will have received more than 620,000 applications.

In order to complete the tasks that come with the application season, the division employs temporary employees to data enter information from the applications. These employees start during the first part of January and continue their work through mid-May when the last of the applications are data captured and processed. A small number of the temporary employees are retained through July to process documentation submitted by applicants who filed incomplete applications.

This section includes data and information relating to applications received during the filing season and the remainder of the year (mostly late applications). Applicant demographics included in this section are compiled from 2001 PFD application data.





Dividend Payment Season

The dividend payment season begins well before the first dividend payments are paid to applicants in October. The payment season actually begins in August when the division starts to coordinate direct deposit transactions with banks and financial institutions participating in the direct deposit program.

In September, the division begins the task of calculating the dividend amount that will be announced by the commissioner of Revenue later in the month. Because there are still applications pending review or completion, the division estimates the total number of applicants who will ultimately qualify for a dividend and takes other factors into consideration when calculating the dividend. The dividend calculation is included in the executive summary section of this report.

Immediately following the dividend announcement by the commissioner, the division compiles payment data to go to financial institutions (for direct deposit) and the state Department of Administration (for direct deposit advices and dividend checks). Processing begins before the first payment date in October to allow ample time for printing and mailing the large volume of dividend advices and checks. Direct deposit advices are printed first so that all direct deposit recipients receive notification before the date they are paid in early October. Checks are mailed to eligible applicants in mid-October.

This section includes data and information related to the payment of dividends in 2001. In addition to payment of 2001 dividends, the division paid prior year dividends in 2001 due primarily to clearance of an inventory of 2000 applications resolved through review and appeals. Some prior year dividend were also paid from applications filed by individuals who turned 18 years old and did not receive a dividend during the prior year.



The division issues dividends for prior years for **two primary reasons**:

- 1. Most 2000 dividends issued in 2001 resulted from resolution of applications in review or appeal at the close of 2000.
- 2. Prior year 18-year-old filers. Alaska Statute 43.23.055 authorizes individuals who hadn't received a dividend during their minority to apply for that dividend when they turn 18 or become emancipated. These applicants must meet eligibility requirements and apply for the prior year dividend within one year of their 18th birthday or date of legal emancipation, whichever comes first.

Other reasons: Disabled adults and estates have an extended filing date of one year later than other applicants.

Legislation establishing the Alaska Education Trust Fund (AS 14.40.807) and authorizing an allowance for applicants to contribute 50% of their dividend to the fund was passed in 1990. The name of the fund was changed in 1991 to the Advance College Tuition (ACT) Payment Fund. The ACT checkoff first appeared on 1991 dividend applications.

In fall 2001, the University of Alaska developed the UA College Savings Plan program as the main program under which persons make contributions toward advanced college tuition costs. The UA College Savings Plan provides different investment strategies to individuals making contributions.

Dividend Information Offices

The division's dividend information offices perform crucial services for applicants who need assistance with their applications or have questions regarding the dividend program. Information offices are located in Anchorage, Fairbanks and Juneau. The offices help tens of thousands of Alaskans through walk-in, telephone and e-mail contact.

Peak seasons for the information offices are beginning of January through March (filing season) and September through October (dividend payment season).

In January through March, the offices receive thousands of applications from walk-ins. Employees assist applicants with questions they have about completing applications and provide information about the dividend program. The highest volume of filing occurs the first two weeks of the January and last two weeks of March.

In September through October, employees field inquiries from applicants who want to make sure they are on file and accepted for dividend payment, and those who have questions regarding their dividend, particularly those who are garnisheed and have not received their dividend.

Although activities peak during these times of year, employees still receive thousands of contacts in the off-season. Contacts during the off-season are primarily from applicants who are completing their application because they submitted an incomplete application; either they didn't answer questions, failed to include requested information, or did not include sufficient documentation with their original application.

This section includes data and information related to telephone and counter activities for 2001 and a comparison to 2000 activities.




2001 Counter Contacts

2001 Telephone Calls


Information office employees respond to thousands of telephone calls each year from applicants requesting assistance. During 2001, employees answered about 112,500 calls.



Two-Year Comparison of Information Office Activity


Counter Contacts

Total counter contacts for 2000 and 2001 were approximately 60,100 and 56,200, respectively. The decrease in counter contacts was related to new processing procedures that resulted in less correspondence with applicants.



Telephone Calls

Total telephone calls for 2000 and 2001 were approximately 97,500 and 112,500, respectively. The increase in telephone activity was the result of the division issuing checks one week following direct deposit day rather than the following day as was done in 2000. Checks were issued one week following direct deposit to allow processing time for direct deposit related transactions.



Dividend Enforcement, Review and Appeals

The Dividend Enforcement, Review and Appeals Unit works inventories of applications that require further scrutiny by the division and appeals from applicants whose dividend was denied


Employees review individual applications flagged during application processing. Employees make eligibility determinations from information submitted with the application and subsequent correspondence with applicants. They consider residency, intent to remain an Alaska resident, absences and physical presence in the state when making determinations. If review staff determines that an individual is not eligible for a dividend, the employee will issue a decision letter notifying the applicant that his or her dividend application has been denied. The letter also notifies the applicant of their right to appeal the decision.

Employees assigned appeals caseloads conduct informal appeal conferences for applicants who disagree with their denial. Employees review each appeal and develop facts and information relating to matters in dispute by the applicant. They issue written decisions to applicants upon conclusion of an informal conference. If the applicant disagrees with the informal conference decision, the applicant may request a formal hearing. A designated employee represents the division at formal hearings.


The unit also fields fraud tips from individuals who are suspicious of an applicant's eligibility to receive a dividend.


Comparison of Cases Worked


