ORDER ADOPTING CHANGES TO REGULATIONS  
OF THE DEPARTMENT OF REVENUE

The attached one page of regulations, dealing with the award of prizes for donations to the permanent fund dividend education raffle, is adopted and certified to be a correct copy of the regulation changes that the Department of Revenue adopts under the authority of AS 43.23.055, 43.23.200, 43.23.220, 43.23.230, and 43.23.270, and after compliance with the Administrative Procedure Act (AS 44.62), specifically including notice under AS 44.62.190 and 44.62.200 and opportunity for public comment under AS 44.62.210.

This action is not expected to require an increased appropriation.

In considering public comments, the Department of Revenue paid special attention to the cost to private persons of the regulatory action being taken.

The regulation changes adopted under this order take effect on the 30th day after they have been filed by the lieutenant governor, as provided in AS 44.62.180.

15 AAC 23.360(f) is amended to read:

(f) An applicant may make a donation under this section, but is ineligible to receive a prize from the dividend raffle fund if the applicant is

(1) employed by the Department of Revenue commissioner's office during

(A) the application period for the dividend year immediately before a dividend raffle fund drawing; or

(B) the 30-day period immediately preceding and including the date of the dividend raffle fund drawing;

(2) a raffle drawing auditor appointed by the commissioner of revenue under 15 AAC 23.370;

(3) a member of the team securing and transporting the drawing container containing raffle tickets; [OR]

(4) an employee within the department that actively assisted in generating dividend raffle tickets; or

**(5) a person who draws one or more winning tickets at the dividend raffle fund drawing.**
